## Section 4. First aid measures

### Description of necessary first aid measures

## Section 5. Fire-fighting measures

## Section 7. Handling and storage

### Precautions for safe handling

Electrical equipment and lighting should be protected to appropriate standards to prevent dust coming into contact with hot surfaces, sparks or other ignition sources. **Conclusion/Summary** : Low acute inhalation toxicity. As with exposure to high concentrations of any dust, minimal irritation of the respiratory tract may occur. Pure titanium dioxide, a minor component of this product, has been listed by IARC as a group 2B (possible carcinogen). This classification is based on rat "lung particulate overload" studies performed with airborne particulate. Toner is not listed by IARC, NTP, or OSHA.
